#### Action Requested: Roll Call Vote

Based on the Calaveras County Registrar of Voters' certification, Directors Blood and McCartney were the only candidates for the open Board seats who filed declarations of candidacy before the deadline. Under the California Public Utilities Code, the Board may appoint them to their new terms in lieu of appearing on the November ballot, which will enable the District to avoid incurring the cost of the election to the County Registrar of Voters. Staff requests that the Board consider making these appointments in lieu of an election.

WHEREAS, pursuant to California Public Utilities Code Section 11852.5, upon certification by the Calaveras County Registrar of Voters that the candidates for office are running unopposed as of the last day of candidate filing, the District may, at a regular or special meeting, appoint said candidates to the Board of Directors in lieu of an election, so long as said appointments are made on or before the 76<sup>th</sup> day before the general election fixed for November 8, 2022, which is August 24, 2022; and
